SNA working on neighborhood safety

The SNA has learned that there were a number of reports of vandalism to cars in the neighborhood around Halloween and again in early December of last year.

In several instances, car windows were smashed and spaghetti sauce was poured over the windshield and hood of a car. One of the cars was apparently an abandoned car that had been parked on the street for over 24 hours. These types of incidents are upsetting so the SNA board asked the Middleton police if this amount of vandalism was unusual and what was being done about it.

Their response was that, although the level of activity doesn't seem to be higher than usual, the reports of vandalism are still being investigated and no one has been apprehended. The suspicion is that some kids or friends of kids in our neighborhood are to blame. The police ask that if anyone knows of anything regarding these incidents to please contact them. They have increased their patrols of the neighborhood as a result – especially at night – and have not had an incident since.

Street parking ordinance

The official rule regarding parked cars is that a vehicle is in violation of street storage after 24 hours (can be ticketed) and is in violation of vehicle abandonment after 48 hours (can be ticketed and towed). Typically, the police respond to citizen complaints on those issues, unless it's obvious (missing a wheel, flat tire, snow plows have to go around it, etc). Residents are encouraged to call the police if they have an abandoned vehicle in the neighborhood.

Stonefield strong-arm robbery follow-up

In our last newsletter we reported that a strong-arm robbery had occurred in our neighborhood on November 9. Apparently, the suspect picked out the victim by the car she was driving and followed her into the neighborhood.

We are glad to report the suspect was apprehended, identified in a line-up by the victim, and is now in jail. He had a preliminary hearing the week before Christmas and was bound over for trial. This case will take some time to be resolved, but in the meantime the suspect will remain in jail on high cash bail as well as a probation hold.

Kudos to the Middleton police for their diligence and swift justice.

The Middleton police offer a number of programs to keep neighborhoods safe. If there is enough interest, we could enlist their help to begin a Neighborhood Watch program. They also offer a service to watch your house while on vacation. More information can be found at the City of Middleton web site.

Traffic Calming Update

The City of Middleton will be sending out ballots sometime this winter to approve the testing of traffic calming measures that were recommended by the Stonefield Road committee (composed of Stonefield residents).

The purpose of the ballot is to allow property owners (mainly on Stonefield and Boundary Roads) the opportunity to approve or disapprove the testing of the calming measures to take place this Spring. If approved, once the test is completed a month later, the same property owners will have an opportunity to react to the test with another ballot and to approve or disapprove the installation of the traffic calming measures.

The committee recommended a combination of medians and traffic circles along Stonefield Road. Those most affected would be property owners whose parking space on Stonefield Road will be reduced due to the median requirements and to Boundary residents who turn onto Stonefield at both intersections.
